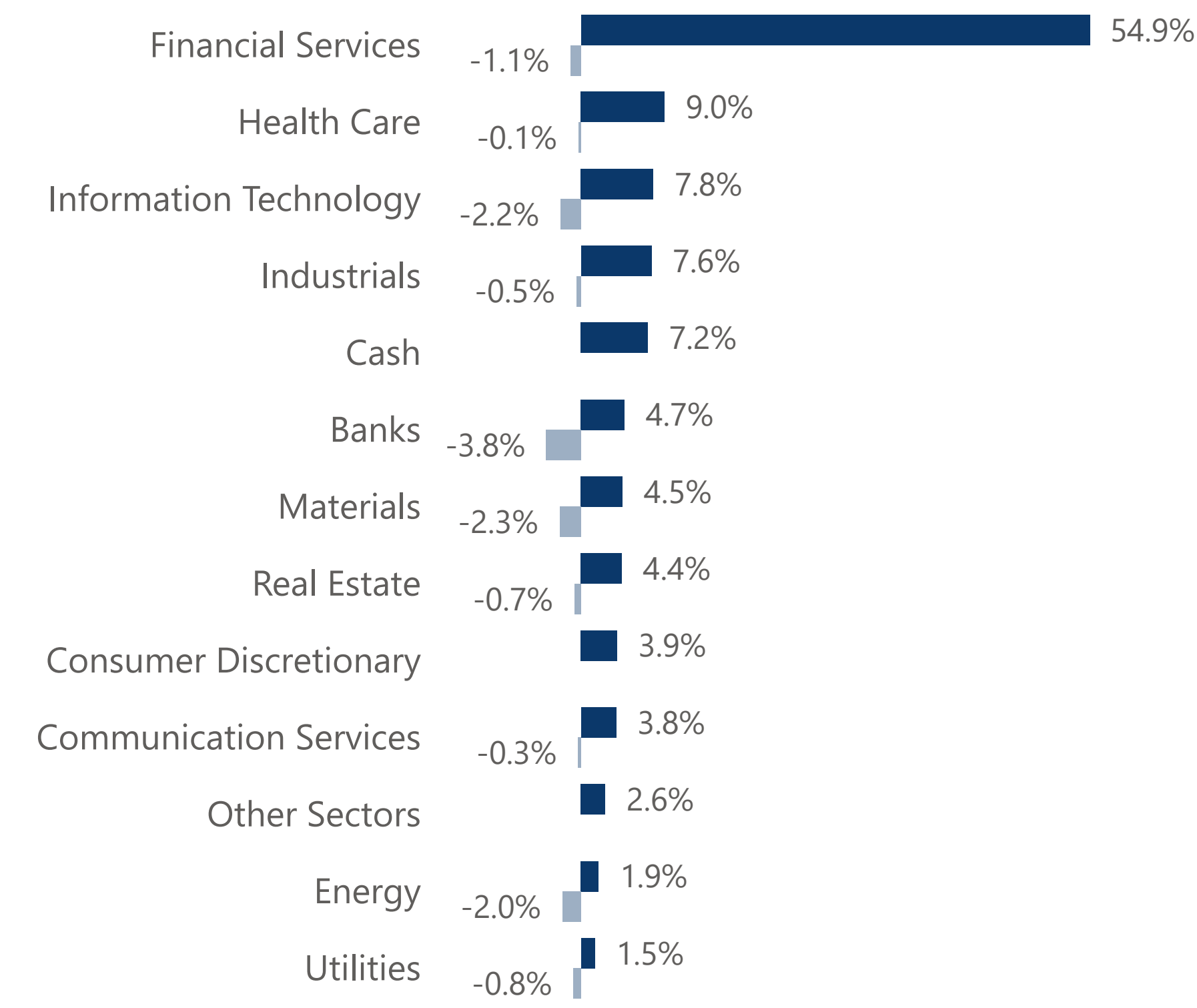

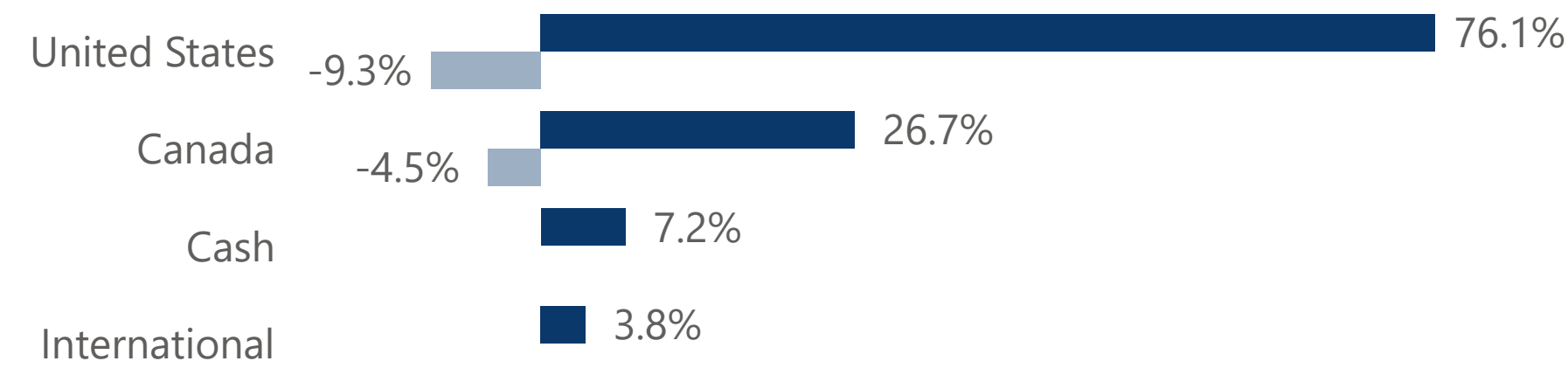

SECTOR ALLOCATION



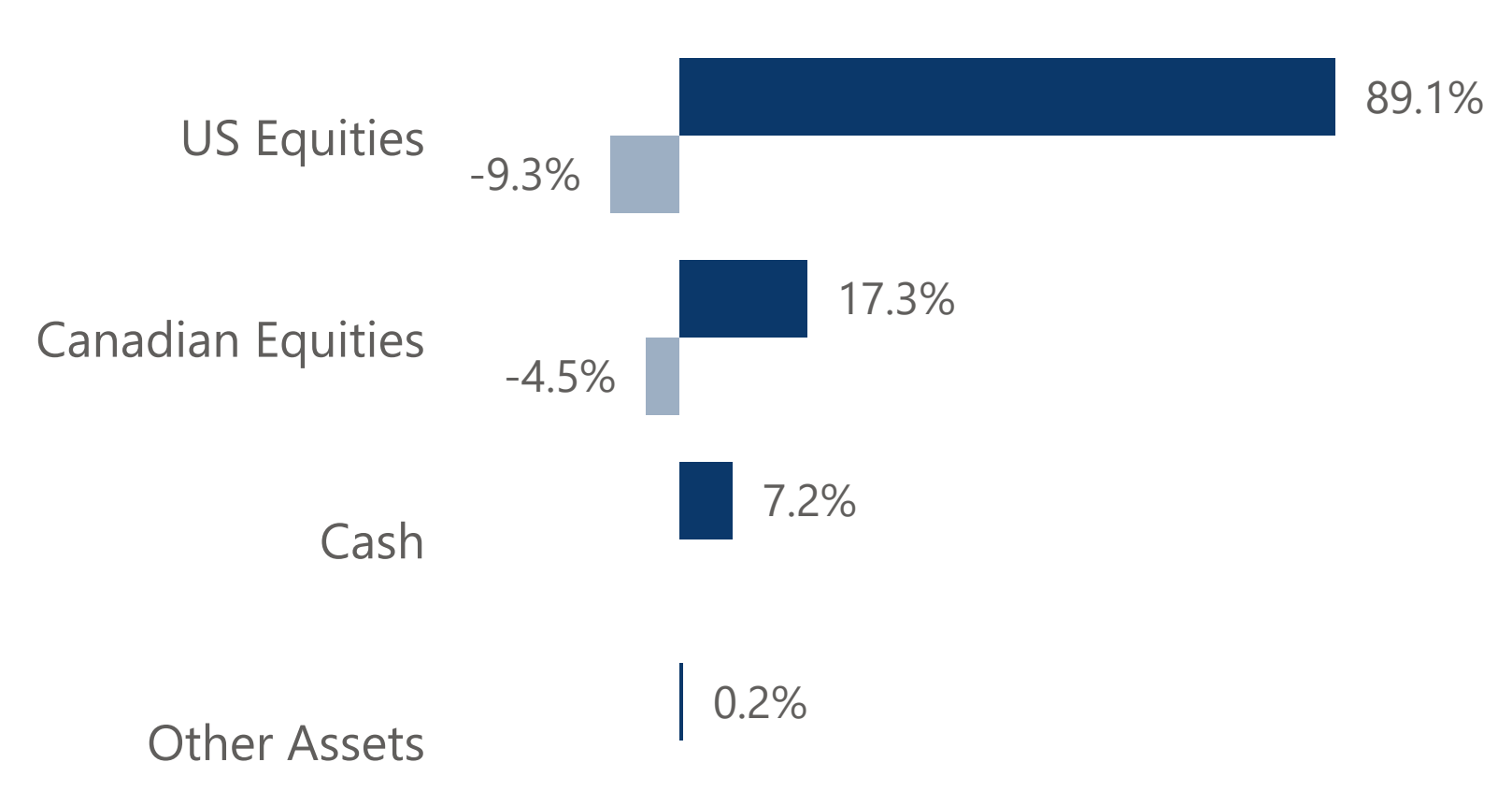

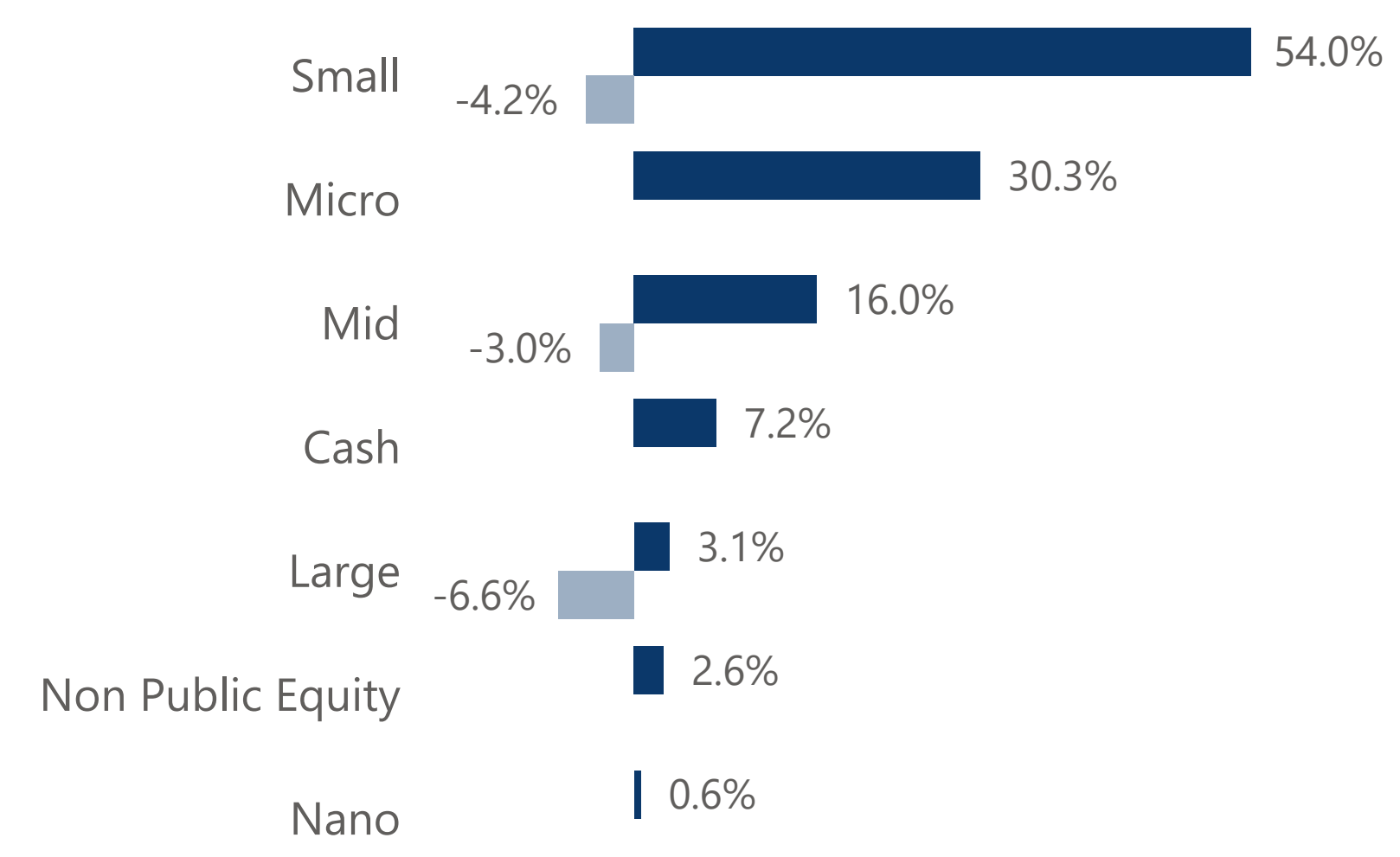
GROWTH OF \$10K
