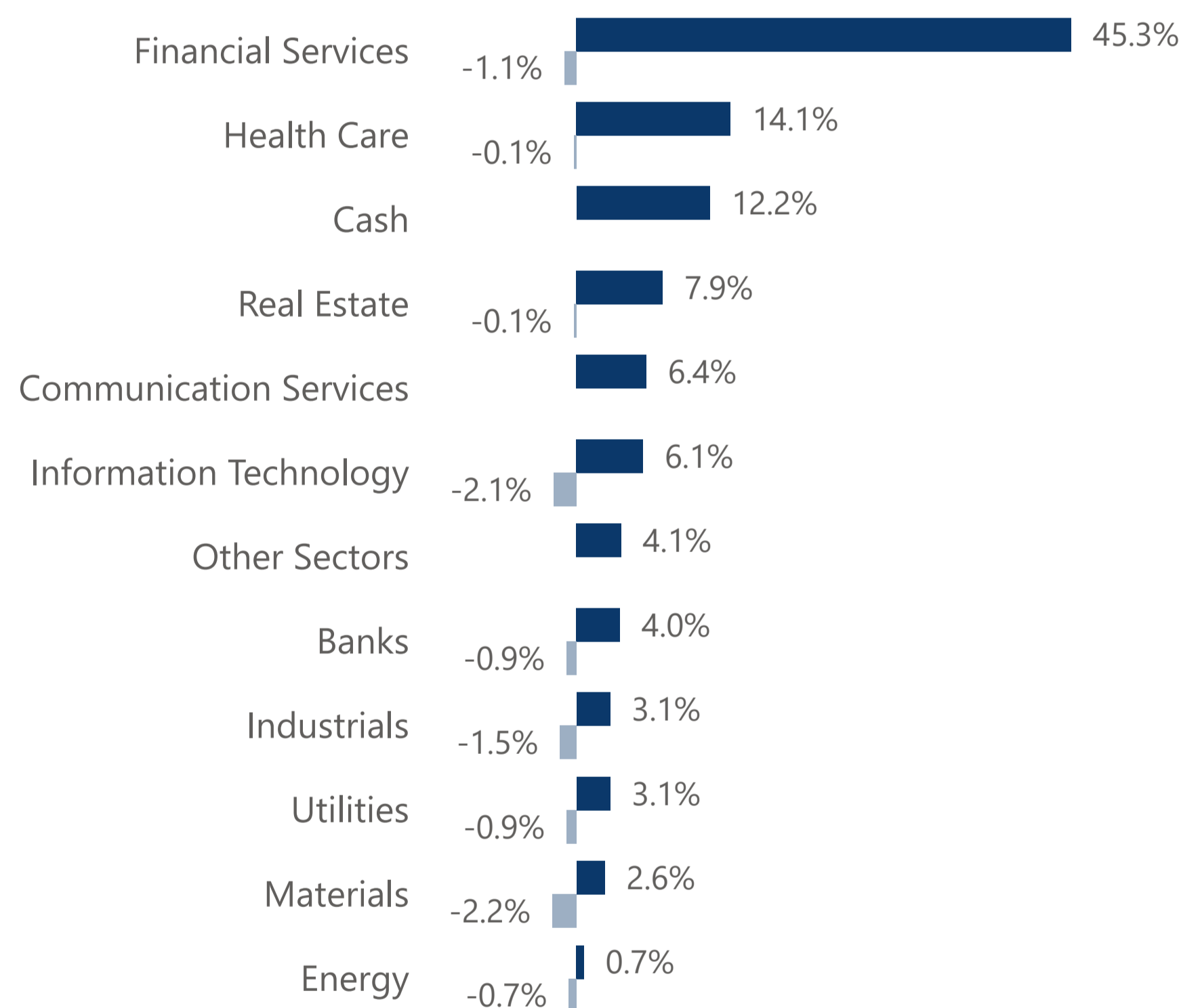

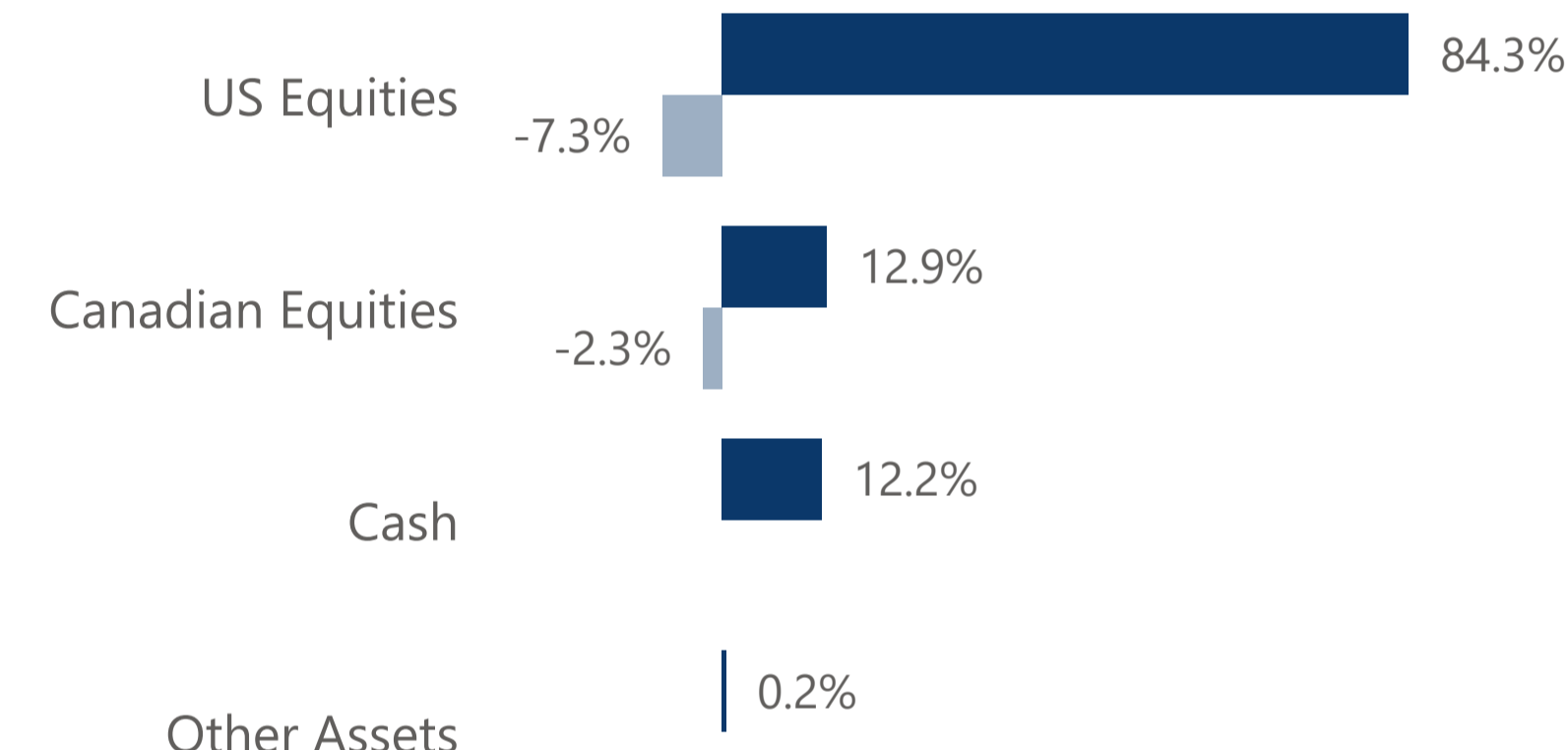

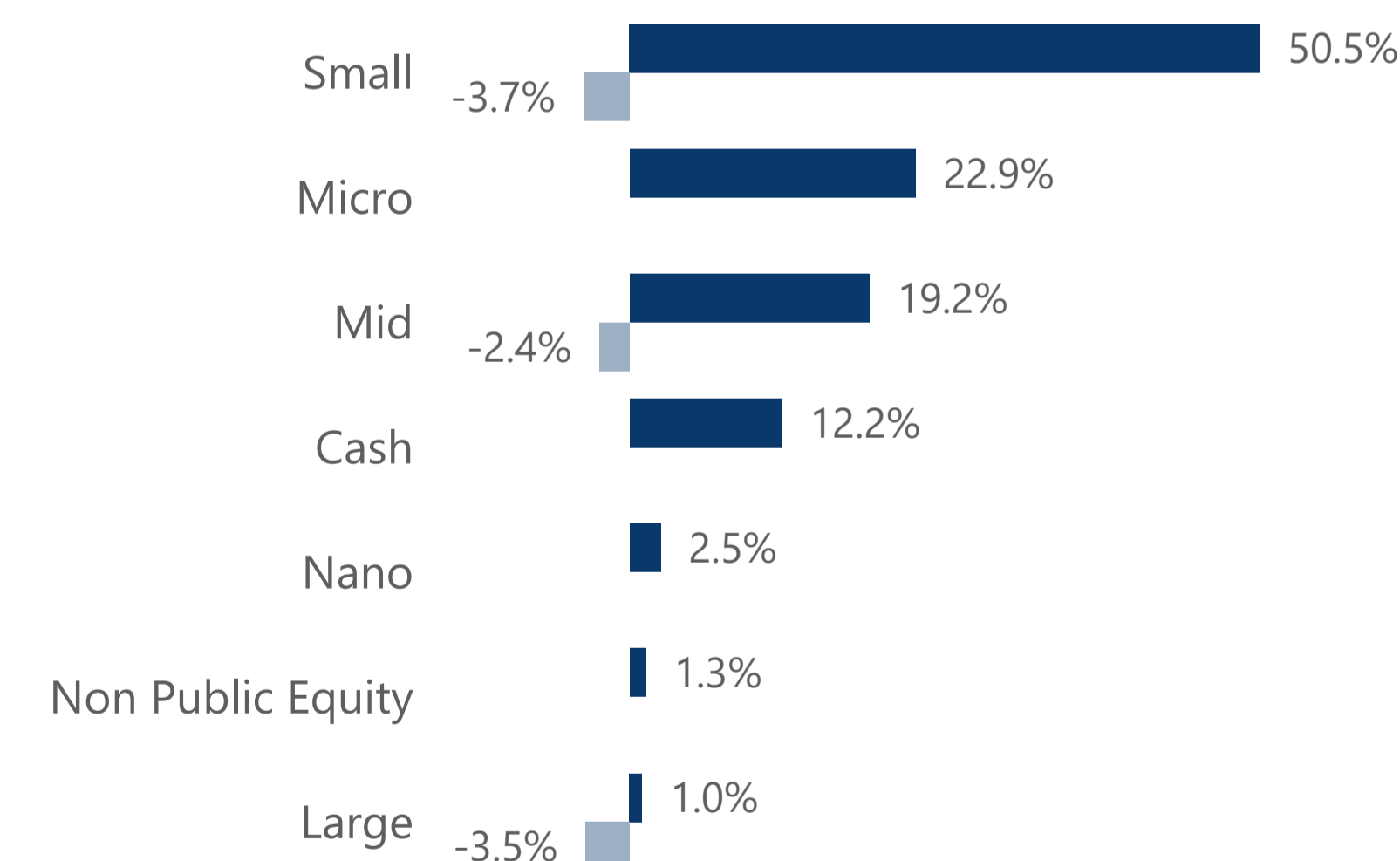
## SECTOR ALLOCATION



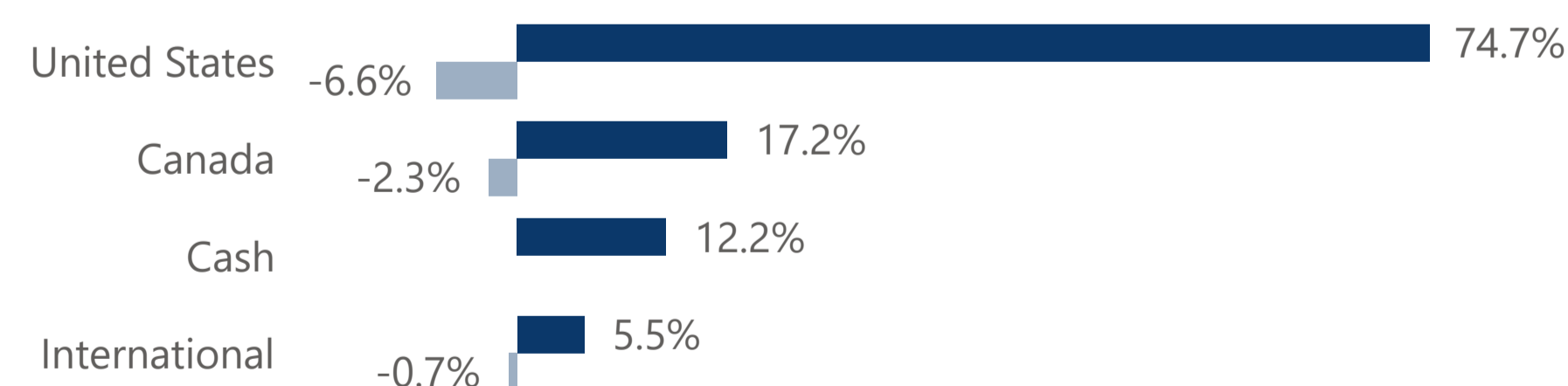
