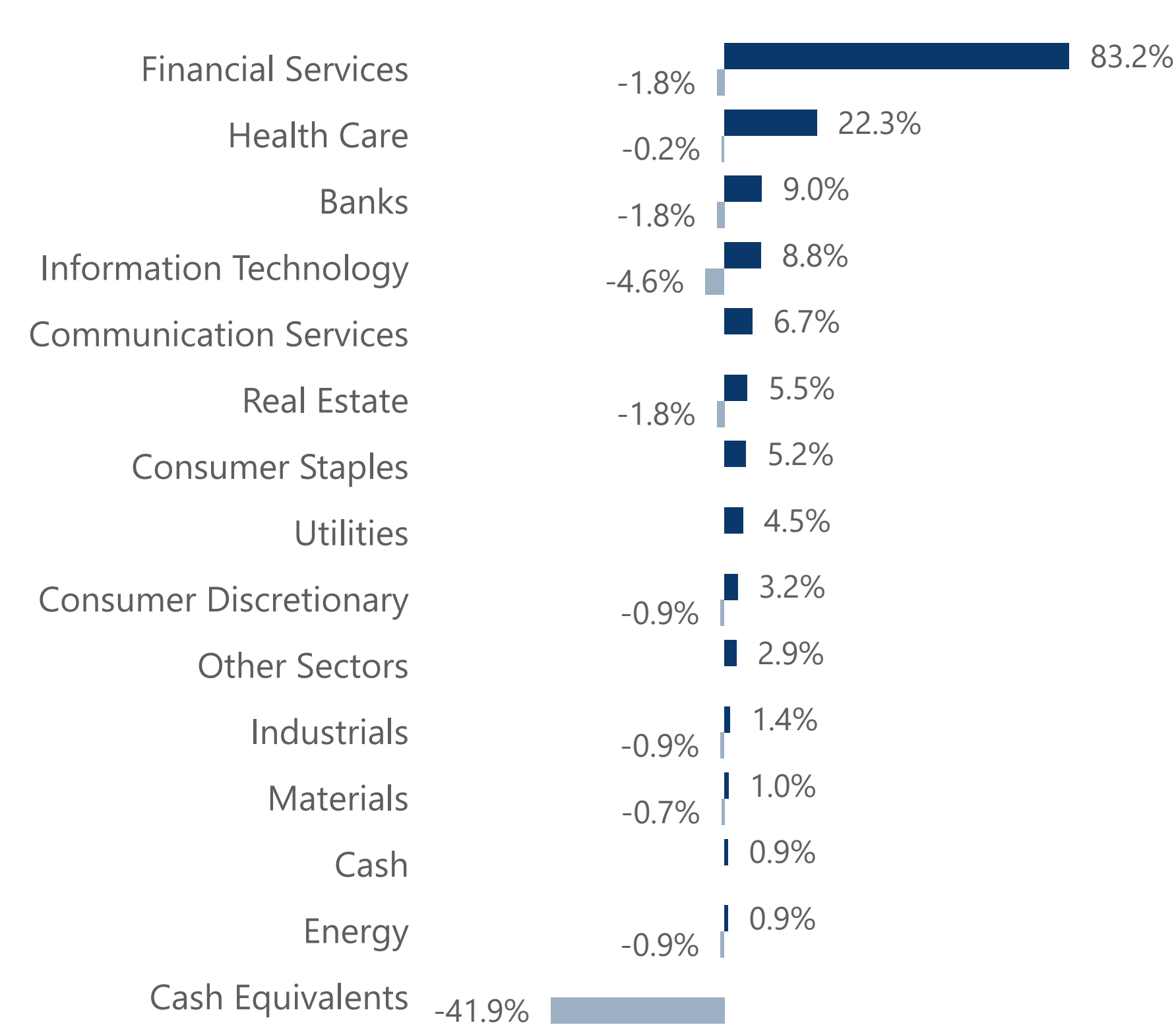

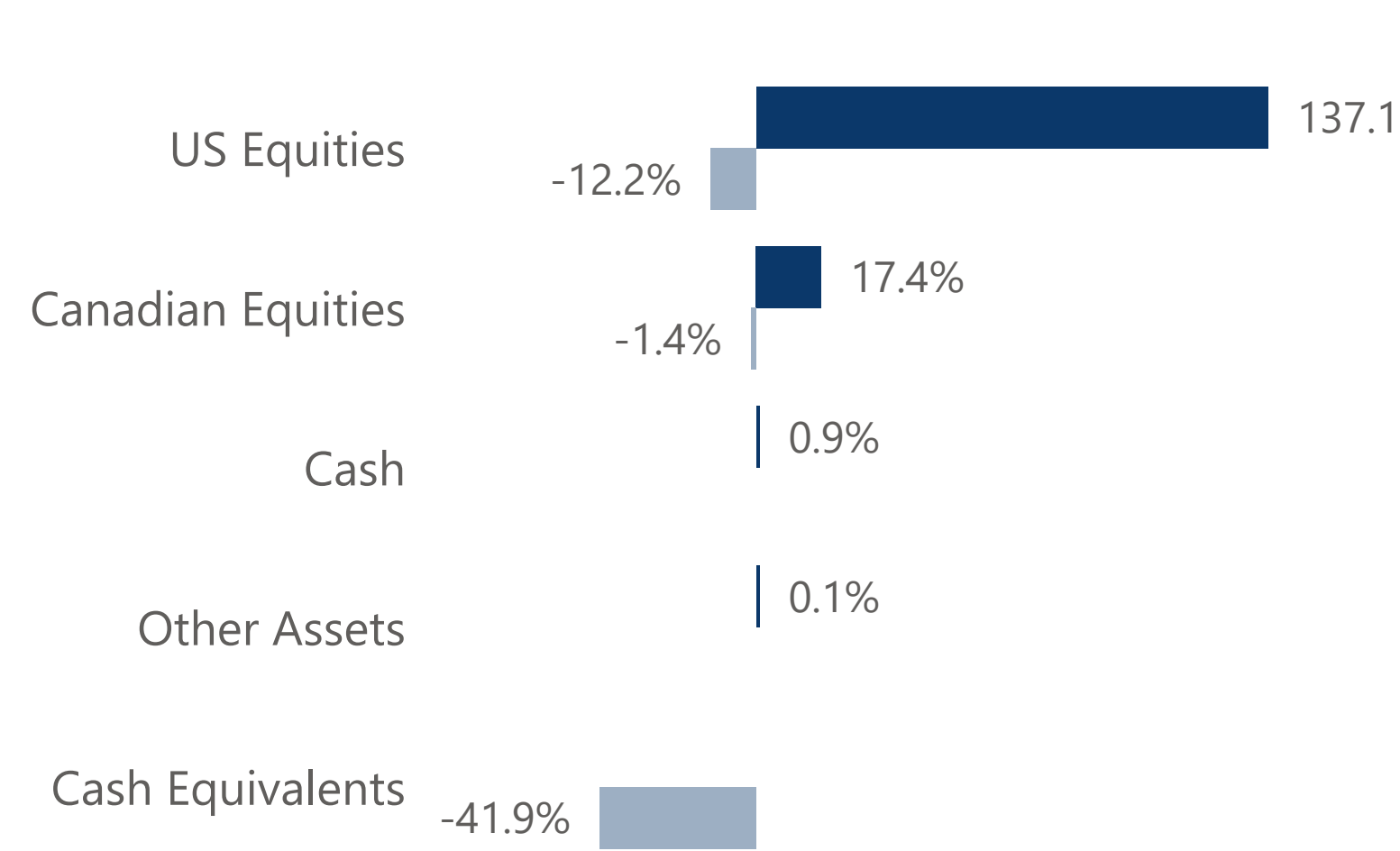

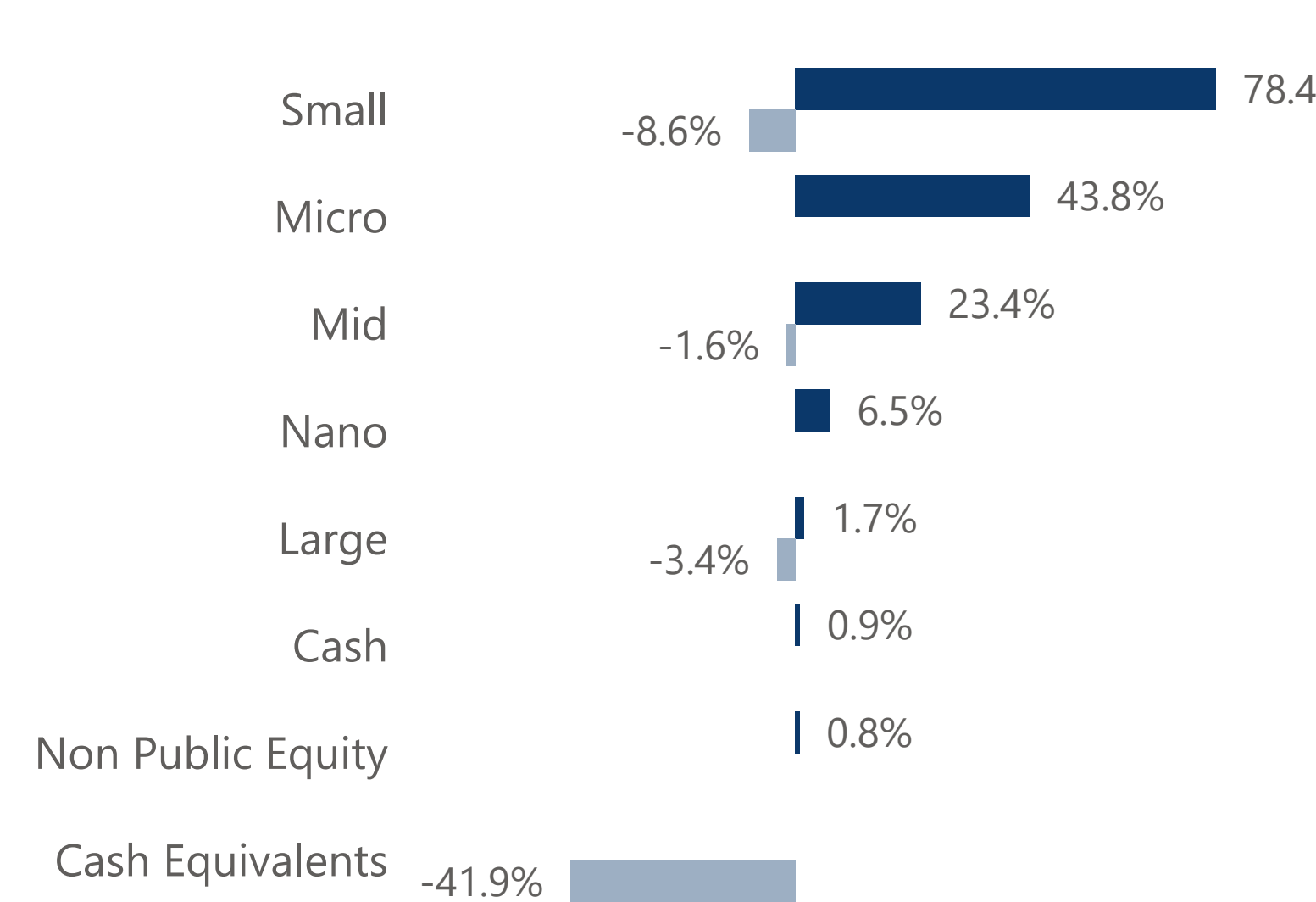
SECTOR ALLOCATION



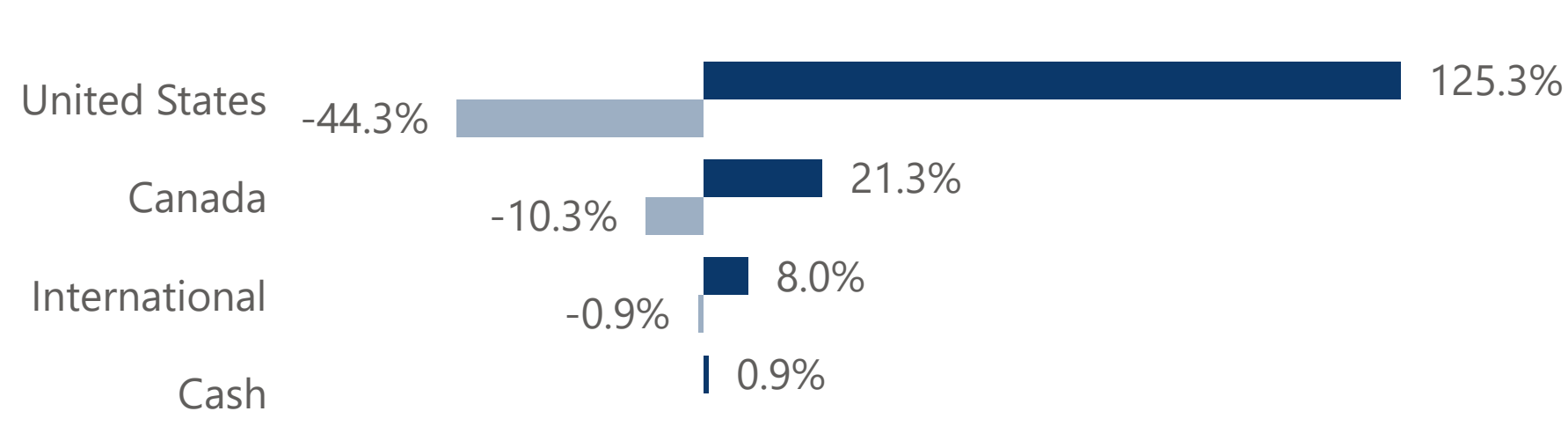
ASSET ALLOCATION



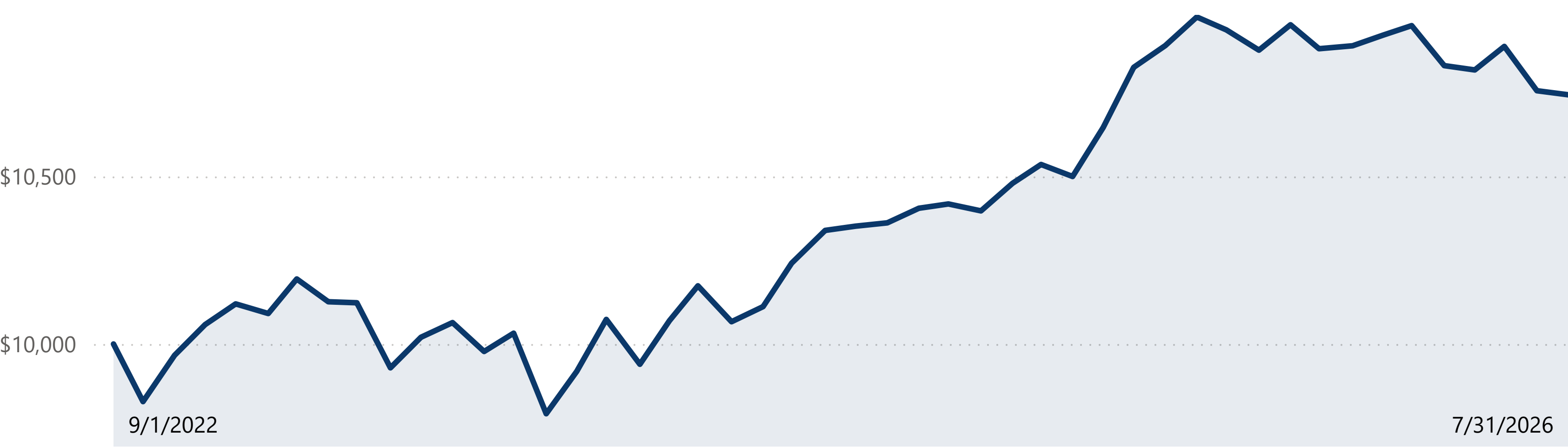
MARKET CAP
