The Fund aims to achieve long-term capital appreciation by investing primarily in Canadian and US equities with the ability to also invest in debt and other securities.

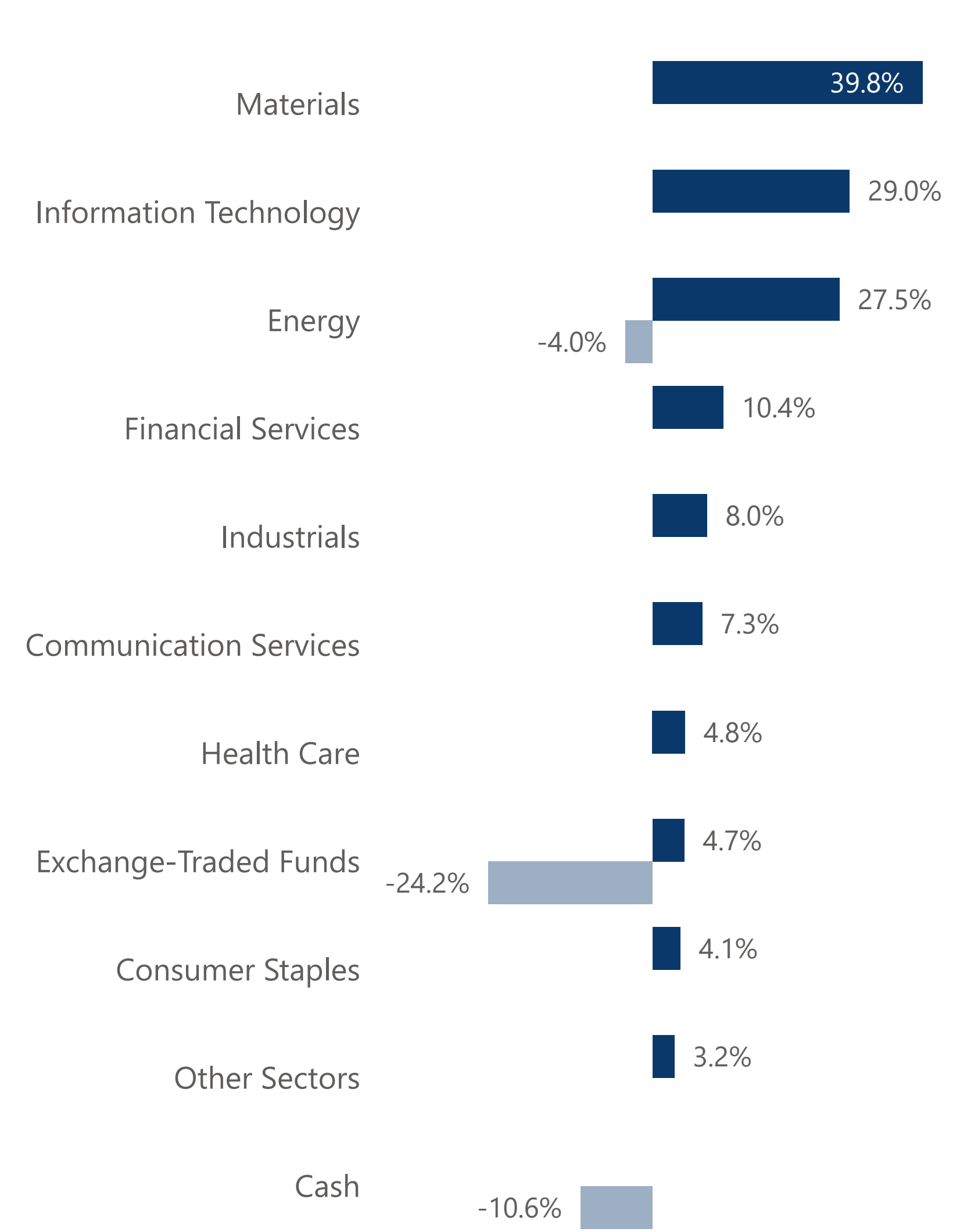

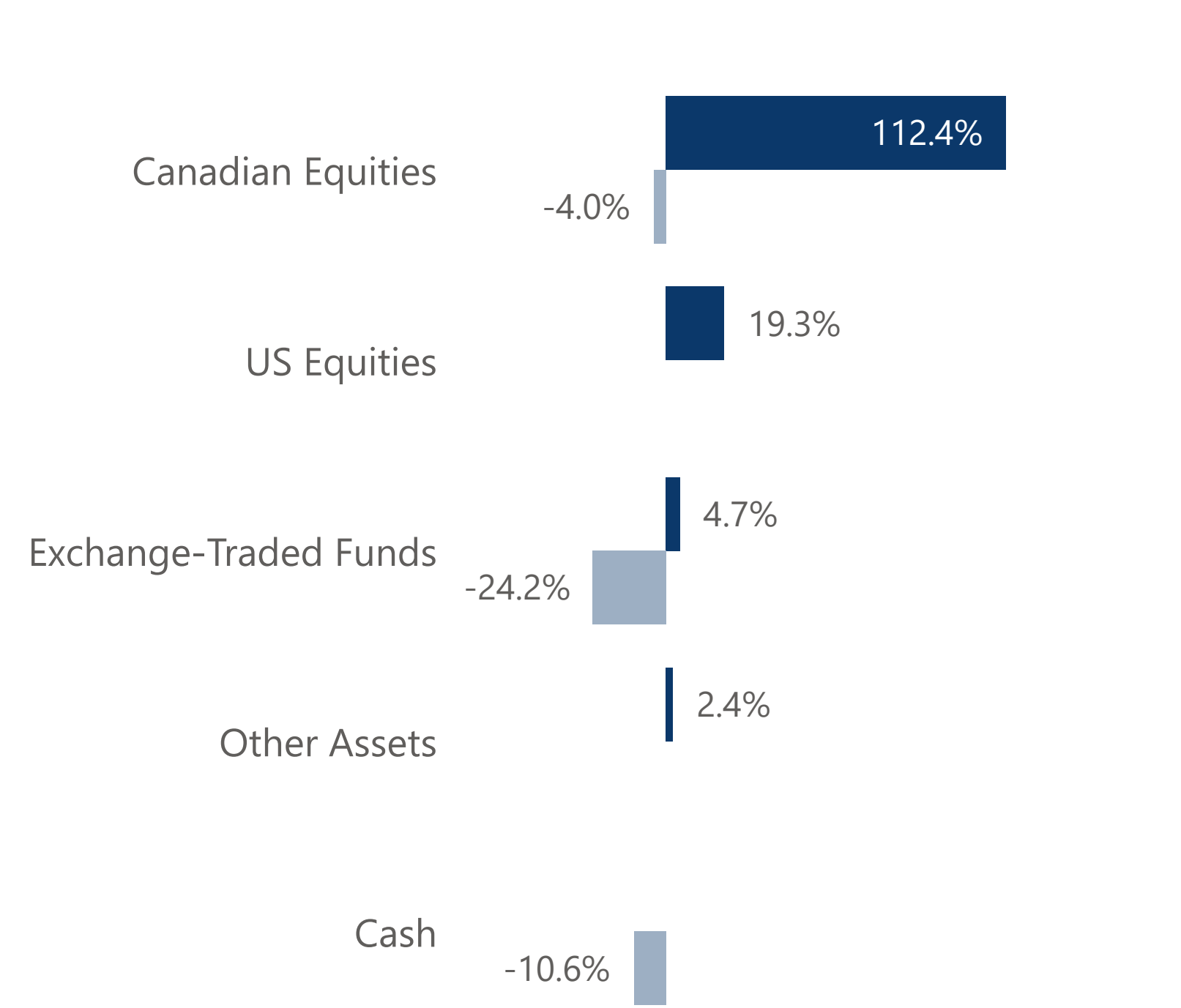

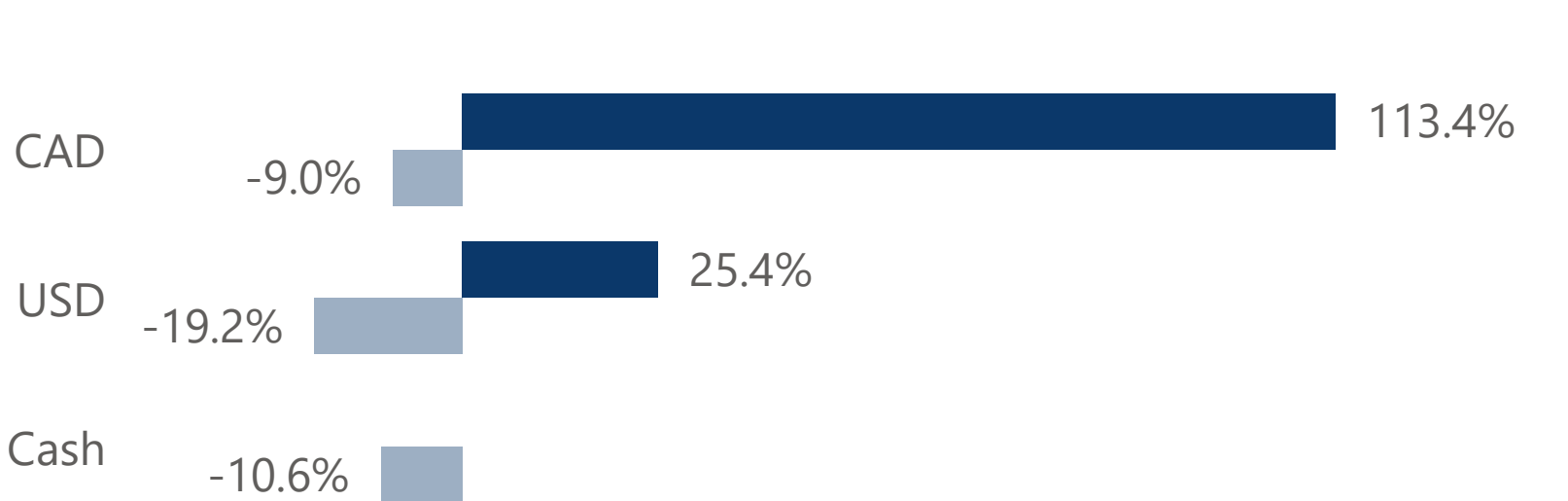
SECTOR ALLOCATION



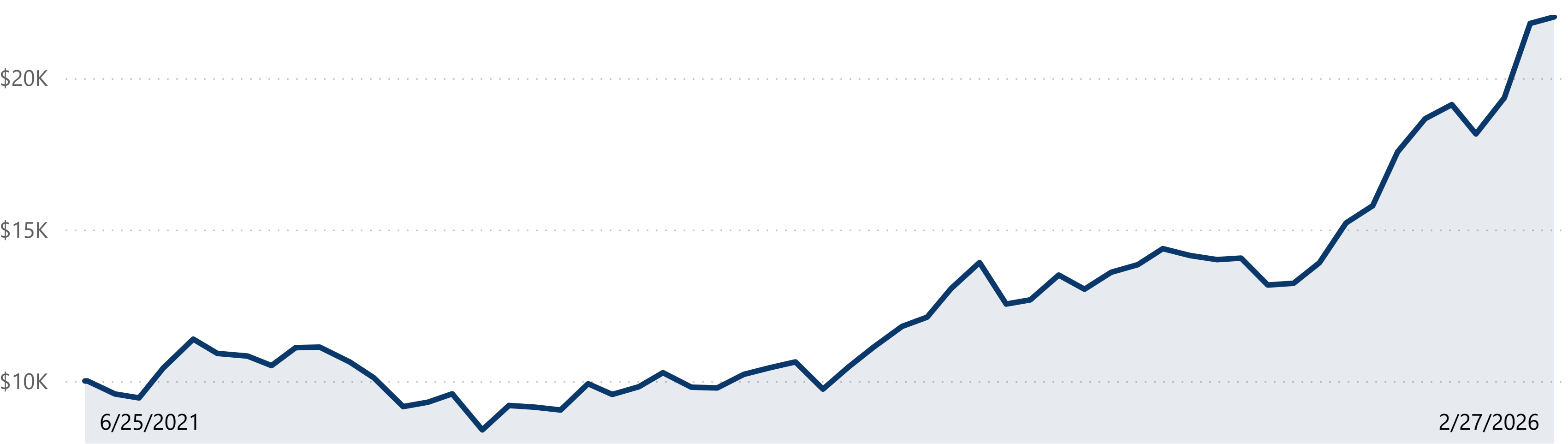
ASSET ALLOCATION
