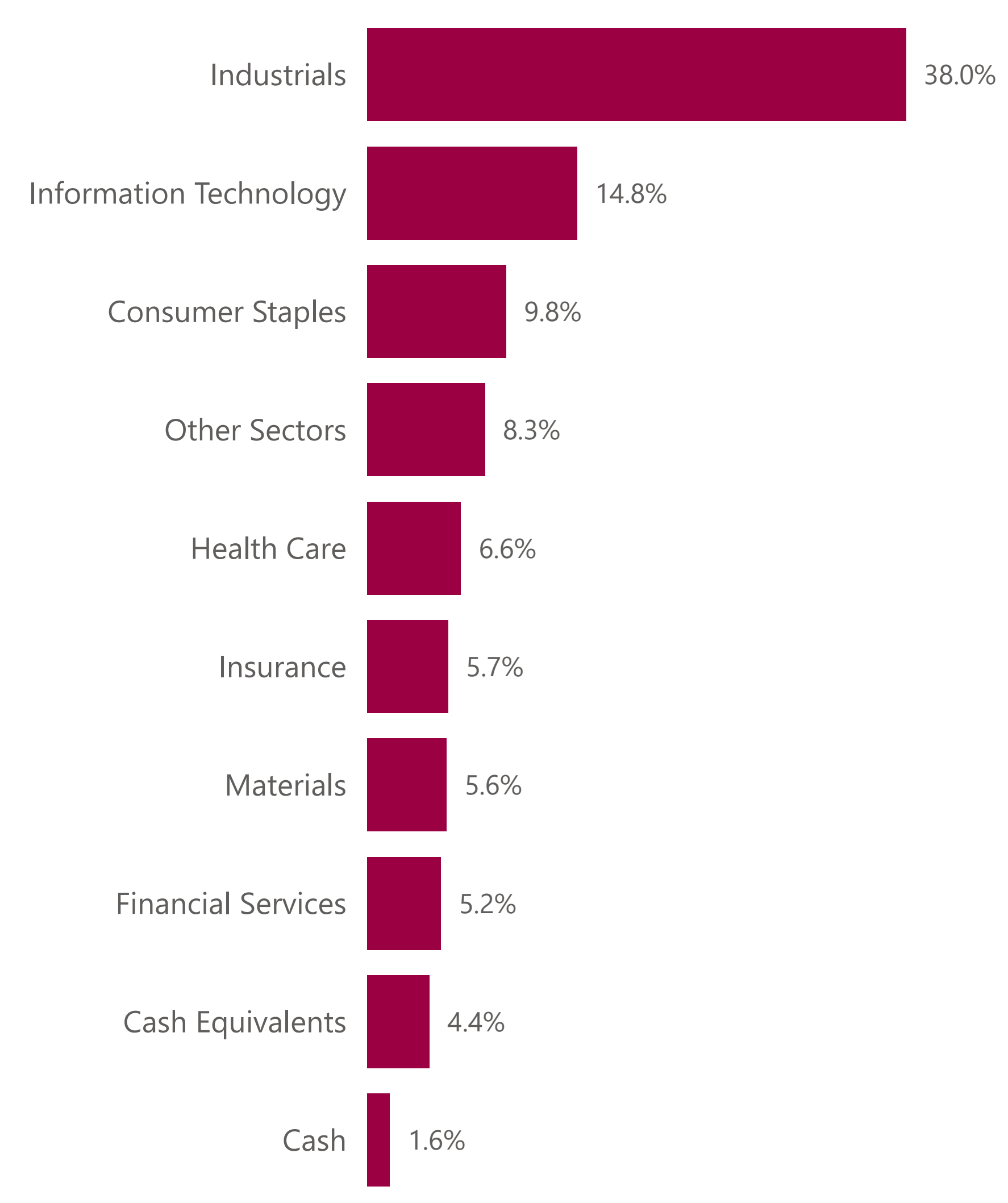

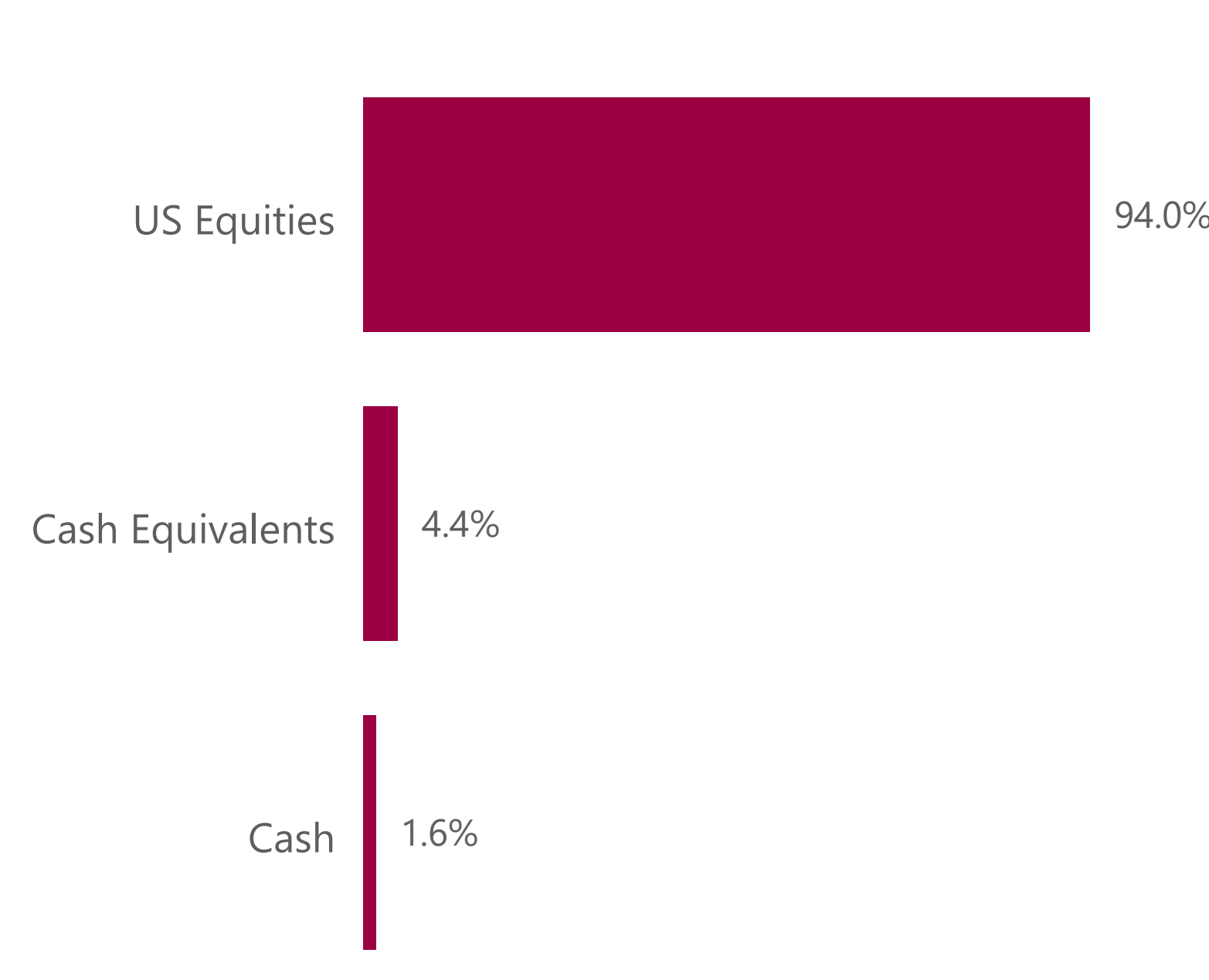

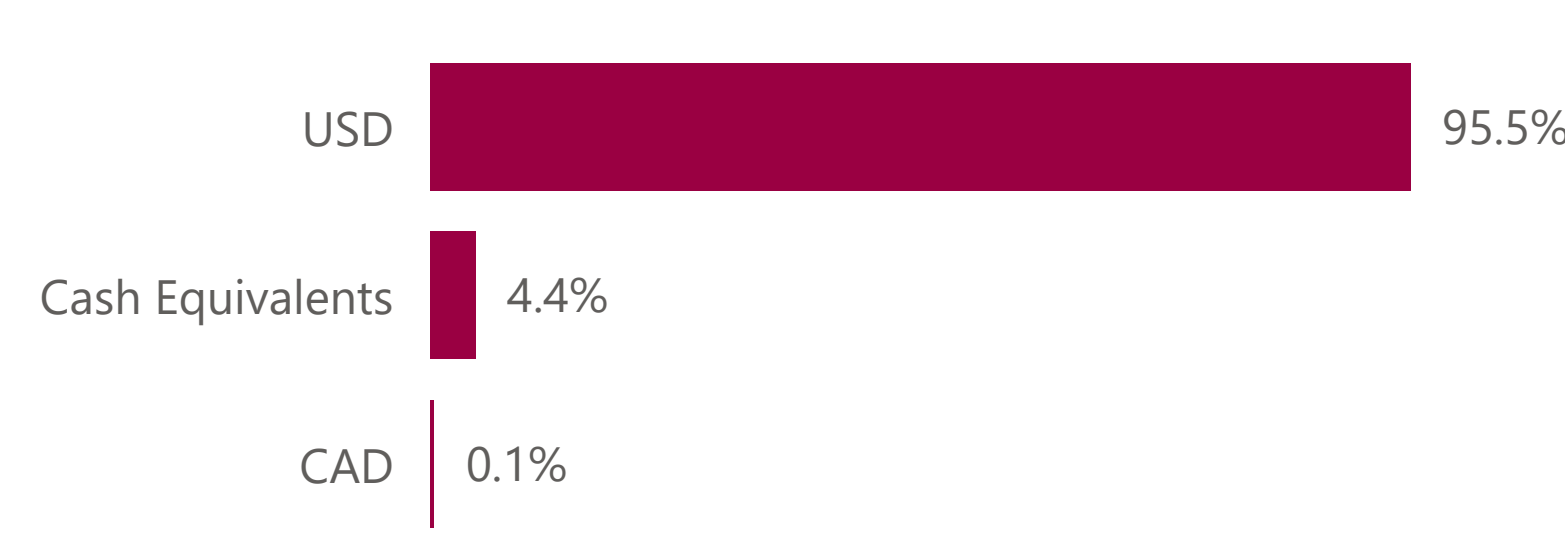
SECTOR ALLOCATION



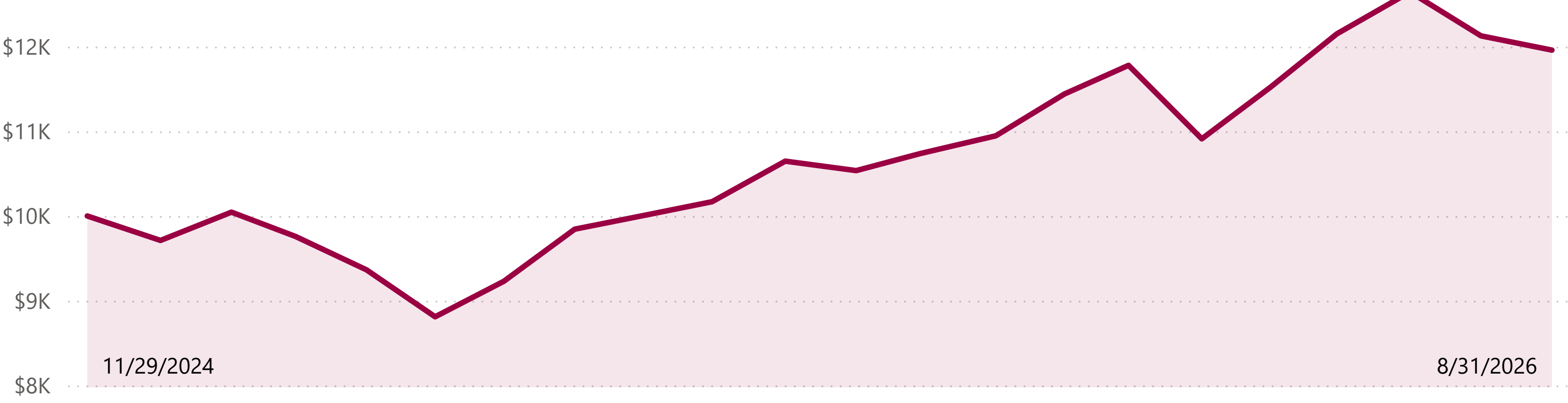
ASSET ALLOCATION
