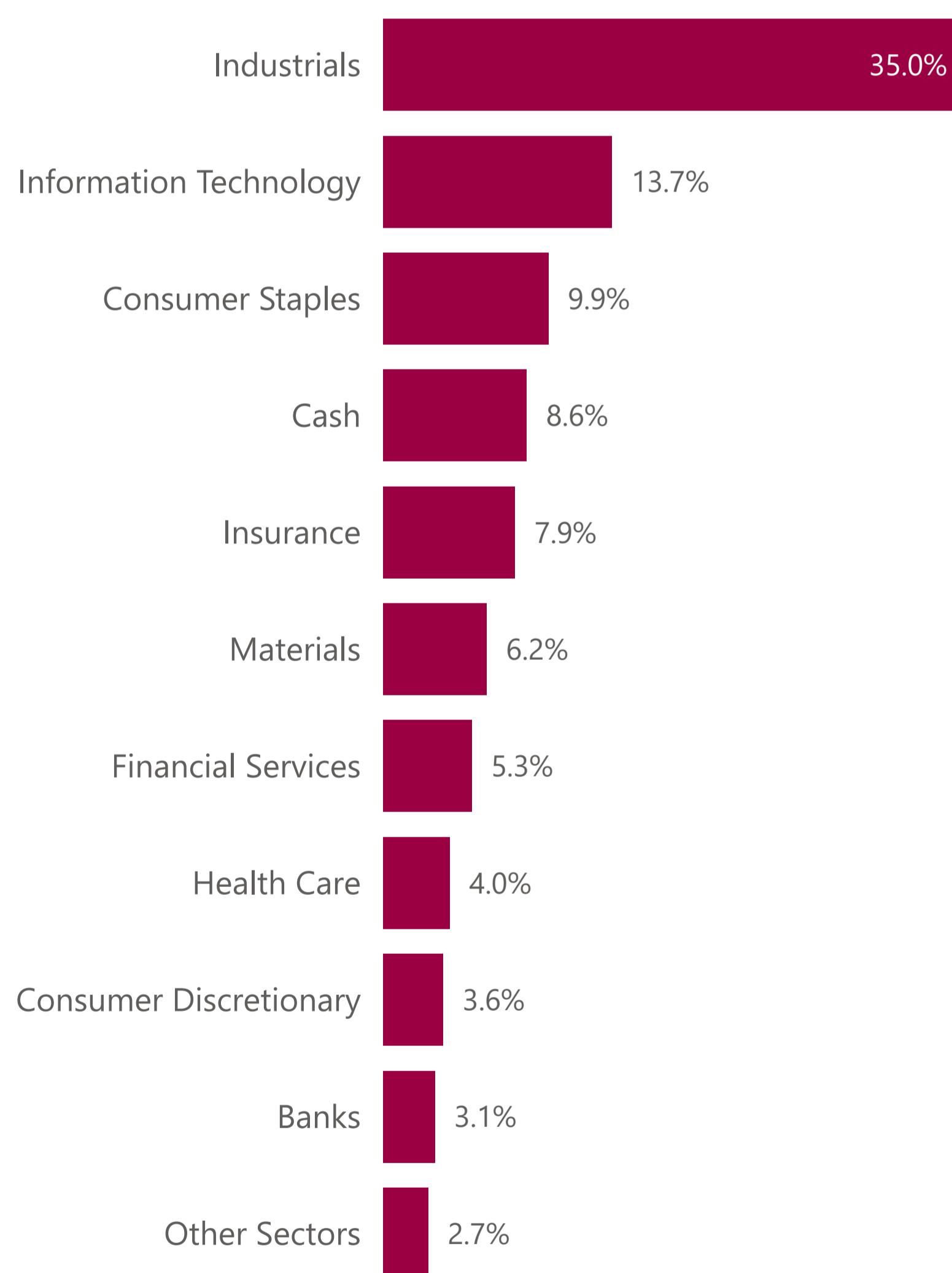

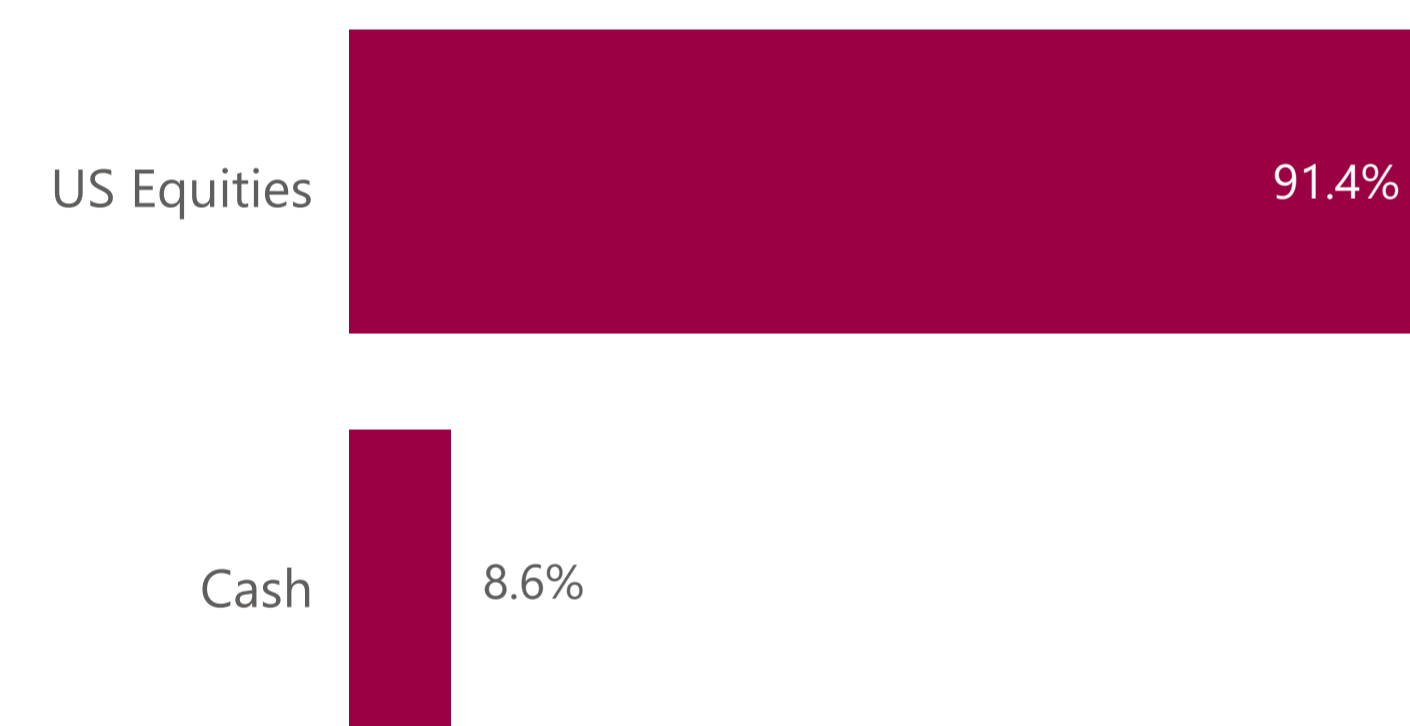

SECTOR ALLOCATION



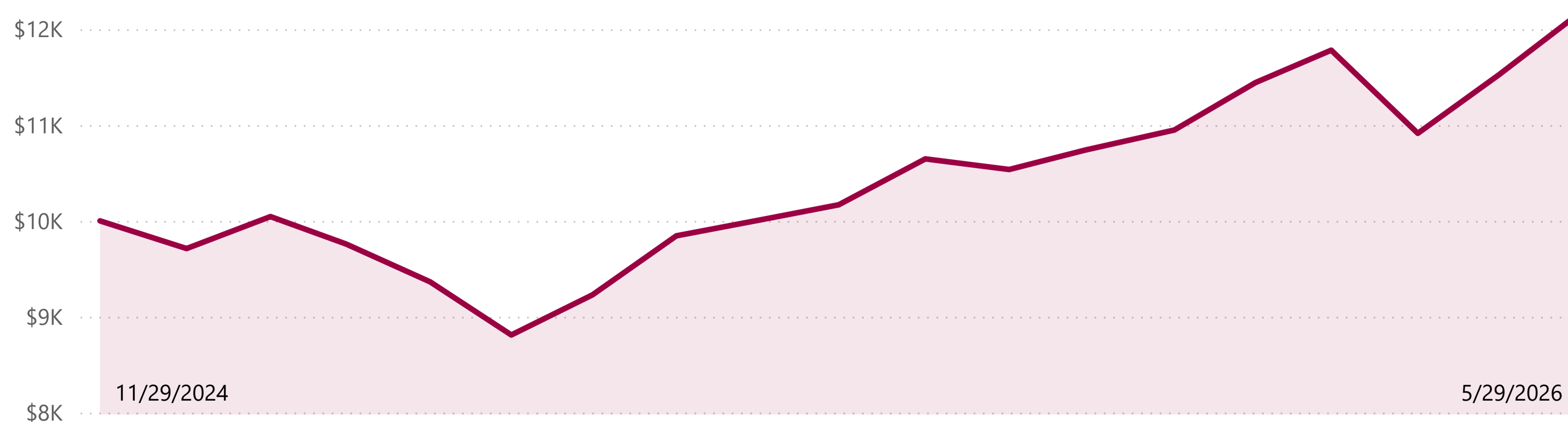
ASSET ALLOCATION
