MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Results of Operations

The net assets of the Pender Bond Universe Fund (the “Fund”) were \$272,225,030 as at June 30, 2026 versus \$126,476,519 as at December 31, 2025. Of this \$145,748,511 increase, \$3,304,679 is attributable to positive investment performance and \$142,443,832 is attributable to net unitholder purchases of Fund units.

For the six months ended June 30, 2026 (the “period”), Class A units of the Fund generated a total return of 1.6%. Returns for other classes also denominated in Canadian dollars of the Fund will be similar to Class A with any difference in performance being primarily due to the different management fees that are applicable to different classes. The return for classes denominated in US dollars will differ from their corresponding Canadian denominated class primarily due to foreign currency. Please see the “Past Performance” section for the performance of the Fund’s other classes.

The Fund’s broad-based benchmark, the FTSE Canada Universe Bond Index (“FTSE”), returned 2.2% during the period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund’s performance relative to the general performance of the market, but we caution that the Fund’s mandate may be significantly different from the index. Further, the Fund’s returns are reported net of all management fees and expenses for all classes, unlike the returns of the Fund’s benchmark, which are based on the performance of an index that does not pay fees or incur expenses.

The Fund’s exposure to credit via its Pender Corporate Bond Fund holdings remains lower relative to historic weightings. The Pender Bond Universe Fund had an 18.7% weight in Pender Corporate Bond Fund units at the end of the period, resulting in a non-investment-grade weight of 11.9%.

The modified duration of the Fund was 4.1 years as at June 30, 2026 and yield to maturity was 4.2%. Cash represented 4.7% of the portfolio at the end of the period.

The following comments and the comments under “Recent Developments” reflect the views of the portfolio management team and are based on information as at the end of the period. Please read the caution regarding forward-looking statements located on the last page of this document.

The Fund’s underperformance relative to its benchmark was mainly due to an underweight in government-related securities.

Key positive individual contributors to the Fund’s performance during the first half of the year were positions in the Pender Corporate Bond Fund, Denison Mines Corp., and McDonald’s Corp. Conversely, positions in Esperion Therapeutics Inc., First Majestic Silver Corp., and Duke Energy Corp. were among the largest detractors.

Recent Developments

Credit markets are entering the second half of the year with a constructive fundamental backdrop. Spreads tightened as strong earnings, resilient economic activity, and healthy investor demand outweighed geopolitical concerns. Falling oil prices and easing Middle East tensions also helped improve risk sentiment and supported corporate credit. Balance sheets, earnings quality, and access to capital have been better than many investors feared at the start of the year. In addition, AI-related capital investment has provided a meaningful source of demand and growth support across several sectors. However, tighter spreads reduce the compensation investors receive for unexpected shocks. Credit markets hit resistance levels in June as high yield spreads touched 263 basis points, the lowest levels since January 2025 before widening modestly to close the month. Inflation, policy expectations, tariffs, new issuance, and geopolitical risk all have the potential to reprice risk quickly.

The markets interest rate outlook changed meaningfully throughout the first six months of the year. Early in Q2, geopolitical tension in the Middle East and a spike in oil prices raised concerns that inflation could reaccelerate. As those tensions eased and oil prices declined, markets initially moved toward the view that central banks could remain on pause and potentially ease policy later in the year. That view became more complicated as the quarter progressed. Labour markets remained resilient, corporate earnings were stronger than expected, and significant investment in artificial intelligence infrastructure continued to support nominal growth. In that environment, the market increasingly moved away from expectations for aggressive rate cuts and toward a higher-for-longer policy backdrop.

Finding opportunities that provide credit fundamentals better than their credit rating or yield can and has in the past been a driver of returns of our investment-grade holdings. Finding such a situation can prove fruitful through spread tightening on the back of a ratings upgrade once that value is recognized by a rating agency or the broader market. Turning over many rocks and digging deep into credit specifics is a cornerstone of our process, one that has served the Fund well in the past and one that we anticipate will continue to drive relative performance. In the non investment-grade portion of the portfolio, however, we continue to find idiosyncratic opportunities and add to high conviction lines that, in our opinion, have the potential to relatively outperform.

Independent Review Committee ("IRC") Appointments & Resignations

Effective March 12, 2026, Robin Mahood stepped down from the Independent Review Committee and Natascha Kiernan joined the Independent Review Committee.

Related Party Transactions

The Fund pays management and administration fees to the Manager for management and portfolio advisory services (see "Management and Administration Fees").

As at the end of the period, parties related to the Manager collectively held nil of the Fund's units. In addition, the Pender Income Advantage Fund, a fund also managed by the Manager, held 1% of the Fund's outstanding units.

As part of the Fund's investment strategy, the Fund invests in Class O units of the Pender Corporate Bond Fund, a mutual fund also managed by the Manager. The Fund does not pay any duplicate management fees on its investment in this mutual fund.

Management and Administration Fees

The Fund pays management and administration fees calculated as a percentage of the net asset value of each respective class. The Management Expense Ratio ("MER") before applicable taxes such as GST or HST for each class does not exceed certain levels as set out in the Fund's offering documents. The fees are calculated at the close of business on each valuation day and are paid monthly. In exchange for the administration fee, the Manager pays the operating costs of the Fund.

Management fees are used by the Manager, in part, to pay sales commissions, trailer fees, marketing costs and other associated distribution costs relating to the sale of units of the Fund. Such expenses represented approximately 9% of the management fees paid by the Fund to the Manager for the period.

(b) Management expense ratio ("MER") is based on total expenses (excluding commissions and other portfolio transaction costs) for the period and is expressed as an annualized percentage of daily average net asset value during the period. The MER may vary from one class of units to another because of differences in the applicable management fees and certain fees and expenses may have been absorbed by the Manager which would otherwise be paid by the Fund.

(c) The Manager of the Fund has agreed to absorb sufficient expenses of the Fund, as necessary, so that the annual MER before applicable taxes such as GST or HST will not exceed certain limits as outlined in the Fund's Simplified Prospectus. The amount of expenses absorbed is at the discretion of the Manager as set out in the Fund's Simplified Prospectus, and the Manager may in its sole discretion cease to absorb expenses.

(d) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.

(e) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. In general, the higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

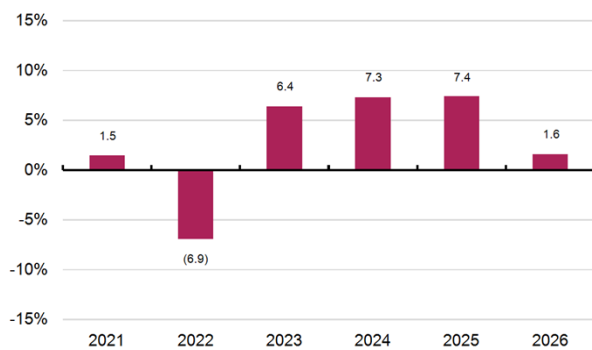
Past Performance

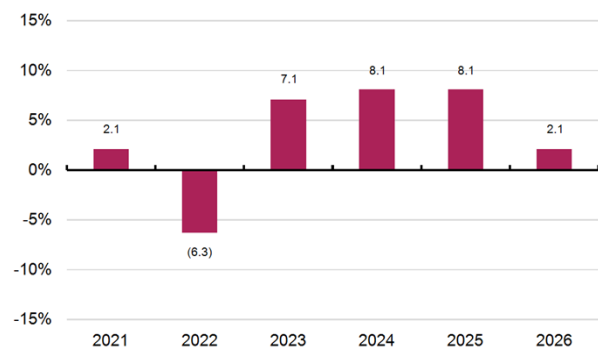
Period-by-Period Returns

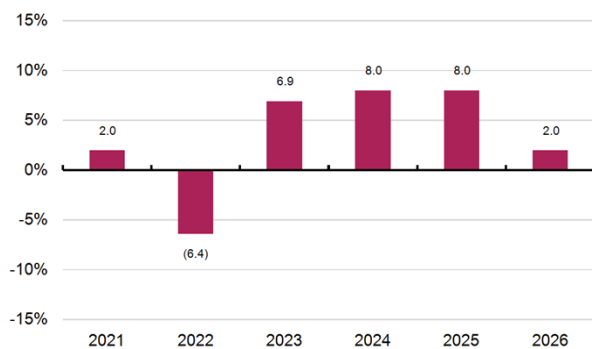

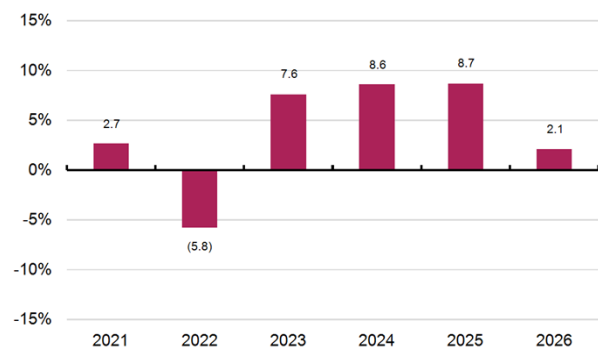

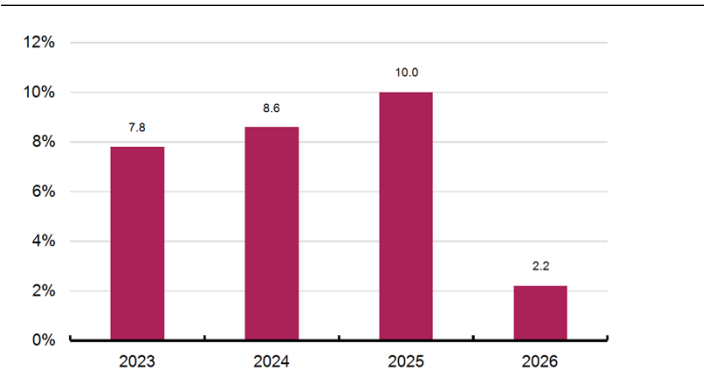
